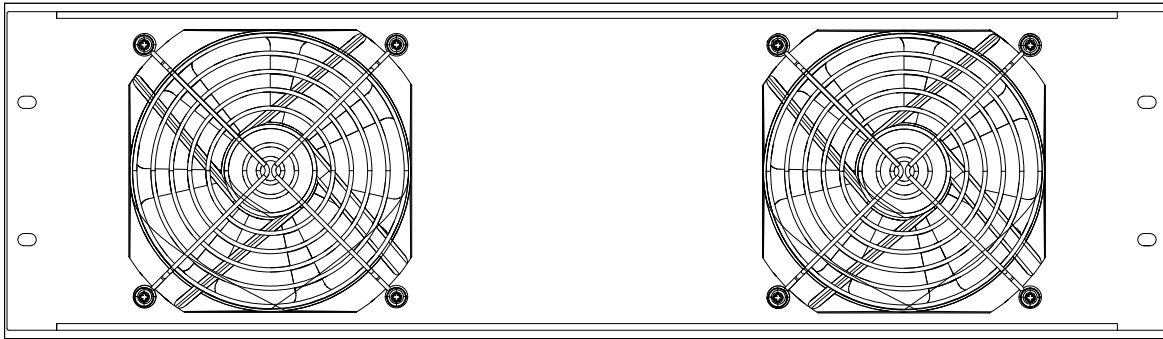

INSTALLATION

- 1) Install fan panel into rack using (4) rack screws (not supplied). **(FIGURE A)**
- 2) Connect Y-cable power cord to power supply. **(FIGURE B)**
- 3) Plug power supply into AC outlet.

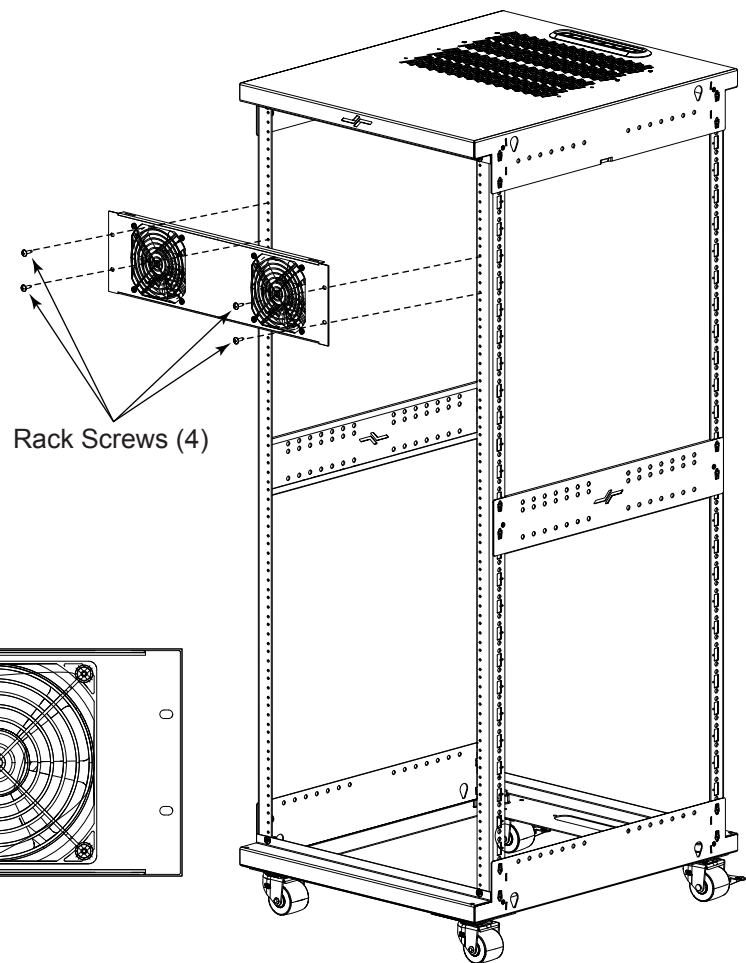

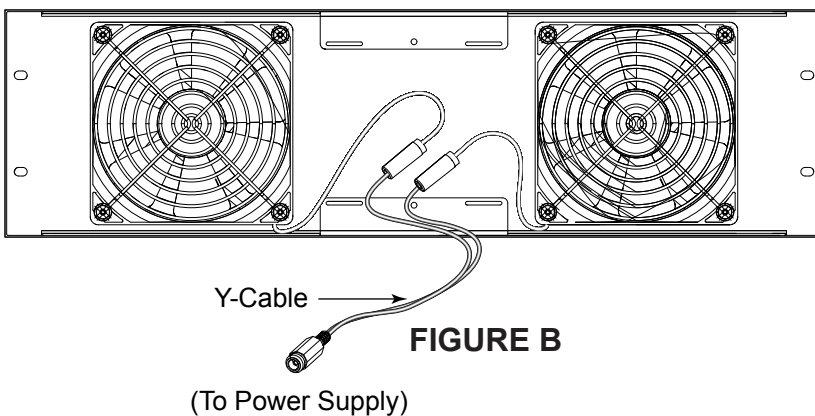


FIGURE B
